PURPOSE

The purpose of this report is to apprise Council of the status of initiatives included in the 2023-2027 Strategic Plan.

BACKGROUND

Council adopted the 2023-2027 Strategic Plan on September 25, 2023, and revised this Plan November 20, 2023. Council's key priority initiatives are included within the Plan which provides clear direction to the organization regarding Council's priorities for this term.

The check-in meeting facilitates public reporting on the Strategic Plan and provides Council the opportunity to reassess priorities and make revisions.

DISCUSSION

The Strategic Plan Dashboard (Attachment 1) provides a list of all initiatives in the 2023-2027 Strategic Plan listed by theme and includes funding information, status, and brief comments. As can be seen in the summary table below, of the 86 initiatives listed, 67 are underway and 11 have been completed, showing progress toward Saanich's Vision. Funding is provided or partially provided for 81 initiatives and consideration may need to be given in future to allow funding to support progress in the remaining areas. See summary table below:

Considerations for unfunded initiatives will be brought forward as part of the future budget processes.

CONCLUSION

The 2023-2027 Strategic Plan highlights Council’s key priority initiatives which provides clear direction to the organization regarding Council's priorities for this term.
