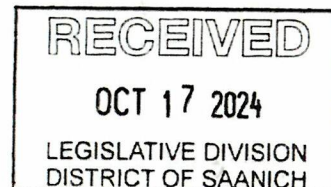

RECOMMENDATION

That Council give three readings to the Heat Pump Financing Local Area Service Bylaws as listed in Attachment 1 to this Report, to establish Local Area Services for the provision of financing for participating properties.

PURPOSE

The purpose of this Report is to bring forward Bylaws which will establish a Local Area Service (see example in Attachment 2) to provide financing for properties that are participating in the Saanich Heat Pump Financing Program.

DISCUSSION

Background

At their March 28, 2022, meeting, Council adopted Heat Pump Financing Service Bylaw, 2022, No. 9761 to establish the Saanich Heat Pump Financing Program. 10 households have been approved for the program as part of the current intake and have submitted a petition (see example in Attachment 3) to create a Local Area Service for the provision of interest-free financing up to \$12,000. The financing will be used to replace participants' fossil fuel heating systems with electric air source heat pumps.

Following the establishment of the Local Area Service Bylaws, participating properties will submit their EnerGuide Evaluations and preferred contractor quote and enter into a Financing Agreement with the District of Saanich. Contractors will then be permitted to complete the work. Upon receiving and approving all required documentation, contractors will be paid directly by the District of Saanich and the financing amount will be added to the parcel tax roll to initiate repayment over 10 years.

Corporate Officer Determination

In accordance with Sections 212(3) and (4) of the Community Charter, the Corporate Officer certifies that the following petitions are sufficient and valid:

In determining the sufficiency and validity of the listed petitions, the Corporate Officer has confirmed that the persons signing each petition are the owners of the parcel that in total represent at least 50% of the assessed value of the land and improvements that will be subject to the local service tax. A letter of certification is appended to this Report as Attachment 4.

ALTERNATIVES

1. That Council approve the recommendation as outlined in the staff Report.
2. That Council approve the recommendation as outlined in the staff Report with amendments.
3. That Council provide alternate direction to staff.

FINANCIAL IMPLICATIONS

The establishment of the Local Area Service in combination with a Financing Agreement will facilitate the District of Saanich's payments to contractors to complete the work and establish the mechanism to recuperate the financed amount through a parcel tax bylaw for participating properties. The District of Saanich has secured \$595,000 in grant funding to support the program and in 2023, Saanich Council approved the establishment of a revolving green fund to continue offering the program and to expand eligibility to all fossil fuel heating systems.

The funding that is provided to finance the upgrades will be repaid to the District of Saanich over 10 years and will be reinvested to allow additional Heat Pump Financing participants.

STRATEGIC PLAN IMPLICATIONS

Implementation of the Heat Pump Financing Program will help achieve Council's Strategic Plan: Climate Action and Environmental Leadership goal, namely:

- Take steps to ensure building stocks address our environmental and climate impact; and
- Implement innovative solutions and practices to reduce emissions, mitigate and adapt to the effects of climate change, and protect the environment.


It contributes to Strategy B2 of the Climate Plan: Accelerate efficiency and renewable energy upgrades in existing buildings; and Action IN2 of the Building Retrofit Strategy: Scale up the Heat Pump Financing (PACE) Program for Part 9 homes.

CONCLUSION

The establishment of the Heat Pump Financing Program in the District of Saanich is helping residents in Saanich overcome the capital cost barrier of replacing their oil, natural gas, or propane heating system with a heat pump, improve affordability, and help the District of Saanich achieve its climate action goals.

The attached Heat Pump Financing Local Area Service Bylaws as appended to this Report will establish the financing service for participating properties.
